**Registration fee is \$15 per student on or before May 5th and \$25 afterwards. Costume rental fees of \$30/student taking 1-2 classes, \$50/student for 3-4 classes and \$70/student for 5 classes or more, are required at the time of registration. Fees are non refundable.**

## Payment Schedule

Payment arrangements are required at the time of registration by VISA or MasterCard or VISA Debit. There are 3 methods of payment:

1. Monthly September 1 through June 1.
2. Per term September 1 and January 1.
3. Pay the year in full by cash, VISA Debit or credit card September 1.

All prices include GST and service charges. No refunds or cancellations given after February 1st. If a student wishes to withdraw from any class, one month's written notice is required (notices not given at the beginning of the month will be deemed given the beginning of the following month). A 5% charge will be applied to all overdue accounts after a period of ten business days and will accumulate an additional 5% charge on the 1st of every month thereafter.

## Waiver
